# Village of Mamaroneck Unveils First Ever Five-Year Capital Plan for Flood Mitigation

The Board of Trustees adopted the Village of Mamaroneck's first ever five-year capital budget program that plans for long-term, large scale capital projects and infrastructure needs over several years. Historically, the Village has implemented a one-year capital plan, but no such budget was adopted over the last three years. It is essential to have a multi-year plan as flood mitigation projects take years to implement from preliminary design and engineering to construction and completion and require significant financial investment.

The approval of the plan comes as the Village, in partnership with Westchester County, advanced two flood mitigation projects into planning, engineering and design, which include the Anita Lane Bridge and Halstead Avenue Bridge. Planning, engineering and design work is expected to begin in early 2026. Westchester County has committed more than \$20 million to these projects.

"The Board of Trustees has pledged to cultivate a new era of transparency and fiscal responsibility, while implementing a long-term comprehensive plan for flood mitigation. Our residents have waited long enough and deserve a solid flood mitigation plan that will address their concerns and improve safety from flood events in our community. County Executive Ken Jenkins has not only pledged

much needed funding but also the necessary resources to work in collaboration with the Village. We are grateful to have a strong partnership with Westchester County and look forward to working together," said Village of Mamaroneck Mayor Sharon Torres.

"Flooding has devastated Mamaroneck time and time again—and we know it will take serious planning,

partnership, and investment to protect this community for the long term. The County is proud to support Mamaroneck and has committed \$22 million to the Army Corps of Engineers project focused on the Village of Mamaroneck and the Mamaroneck and Sheldrake Rivers. We applaud the Village for this forward-thinking capital plan, which prioritizes infrastructure improvements that will safeguard lives, homes, and local businesses," said Westchester County Executive Ken Jenkins.

More than half of the Capital Plan will support flood mitigation efforts, the number one priority among Village residents, to address chronic flooding in the Village. The first year of the Capital Plan is more modest to align with the Village's efforts to stabilize the Village's current financial position.

During years two through five, the continued on page 4

#### Mamaroneck Town Board Approves 2025 **Budget Changes**



The Mamaroneck Town Council approved a few Budget Amendments at its August 13 meeting. Treasurer Tracy Yogman said that there was only one Budget amendment with the Ambulance Corps to level up some of the expense lines needing additional funding, having no effect on the Budget bottom line because interest earnings have exceeded the Budget.

"The declining interest rate was not as extensive as originally planned, so we are adding a little more interest on the Budget. The major expenses are for Workers Comp (an additional \$10,622.57) and insurance," she said. The changes were approved by Roll Call Vote.

The next item was Consideration of 2025-26 School Tax Warrant. "Each year the Town collects the Tax Warrant for the Mamaroneck School District and some of the Scarsdale School District. This year the Mamaroneck Tax Levy increase is 4.9 percent and an additional 6.5 percent for Scarsdale, only 250 parcels of the whole

Village. The Mamaroneck Net Amount to be raised by taxation is \$146,443,220.78.



Mamaroneck Town Council Supervisor Jaine Elkind Eney opened the Board

meeting with the July Fire Report. There were a total of 125 alarms, total personnel responding, 968; total time working, 66 hours and 12 minutes, according to Eney.

Finally, the board approved a proposed Local Law to create of New Parking Permits in the Town's Parking Lots. There are seven types of permits: 1) meter parking permits; 2) daytime parking permits; 3) daytime non-resident parking permits (limited to twenty per year); 4) overnight parking permits; 5) twenty-four-hour parking permits; 6) one-day single use parking permits; 7) area business parking permits.



#### Mamaroneck Chamber of Commerce Launches "Welcome to Mamaroneck" Beautification Campaign

At its Annual Barbecue hosted at Hampshire Country Club, the Mamaroneck Chamber of Commerce officially launched "Welcome to Mamaroneck," a beautification initiative developed in collaboration with the Village of Mamaroneck. Village expects to make significantly higher capital investments with more than \$9 million per year allocated to flood mitigation while the other proposed projects will support economic development, housing, public safety, parks and recreation and urban mobility.

The Village has retained Choice-

Words as its grant writer to secure additional funding sources to support the Capital Plan and flood mitigation, which will be funded through a combination of grants, county, state or federal aid, and the Village reserve fund. The Village will also use bonds from debt service paid through the operating budget.

#### The STEM Alliance Coordinates a Statewide Conference to Advance Digital Equity

The STEM Alliance was a proud leader of the New York State Digital Equity Network's (NYSDEN) 2025 Annual Conference on August 5, which reached full capacity with over 100 participants from across the state. This annual digital equity summit was held in partnership with the Center of Excellence in Wireless and Information Technology (CE-WIT) at Stony Brook University. alignment across work-



Keynote speaker Dr. Revati Prasad, Executive Director of the Benton Institute for Broadband & Society, brought forth powerful lessons on coalition building from Francesca Polletta's book, Freedom in an Endless Meeting: Democracy in American Social Movements. She urged attendees to organize with purpose: "Coalitions are essential infrastructure for accountability, inclusion and funding. They ensure that digital inclusion remains a priority."

Assemblyman Steve Otis said, "Continuing the success of the 2024 NYSDEN conference in Syracuse, this year's event convened New York's leaders in providing digital access and literacy to individuals and families excluded from technology tools essential for life today. The conference focused on the challenges of funding these pro-

grams, the importance of educating officials and the public about the disparities that exist, and strategies for providing programs for those in need. The vitality of NYSDEN, the collaboration of the NYS ConnectALL office, and the partner-ship with organizations providing programs for job training, health care access, education, and library services was underscored throughout the 2025 Conference."

As the conference rotates across the state annually, the NYSDEN team announced that next year's convening will take place in Albany. The 2025 gathering not only supports the implementation of New York State's Digital Equity Plan, but also strengthens ConnectALL's goal to increase the state's digital inclusion capacity through coordinated, com $munity\hbox{-}driven strategies. The work continues.$ With growing regional coalitions, stronger cross-sector partnerships, and a network of over 100 statewide practitioners, NYSDEN is building the foundation for sustainable, equitable access for all. As one participant shared, "While federal funding for this work has been paused, our momentum has not. That's very evident in the room today." NYSDEN is looking forward to increased membership and work in the coming year, as New York continues to lead the nation in digital inclusion.

# What Happens in New York if You Die Without a Will?

Thinking about death is never pleasant, but understanding what happens to your money, home, and belongings if you pass away without a Last Will and Testament is important for protecting your loved ones. In New York, dying without a valid will is called dying "intestate." When that happens, state law—not you—decides who inherits your property. The rules are set out in the New York Estates, Powers and Trusts Law (EPTL), and they may not match your wishes.

When a person dies intestate in New York, the process is handled through the Surrogate's Court in the county where they lived. The court appoints someone to manage the estate—called the "administrator." This person collects the deceased's assets, pays outstanding debts and taxes, and then distributes what remains to the heirs determined by law. The law creates a family tree of priority, starting with the closest living relatives.

Here is how the basic inheritance order works in New York:

- If you leave a spouse and no children: Your spouse inherits everything.
- If you leave children but no spouse: Your children inherit everything, divided equally. If a child has died before you but left their own children (your grandchildren), that share passes down to them.
- If you leave both a spouse and children: Your spouse inherits the first \$50,000 plus half of the remaining estate. Your children inherit the other half, divided equally.
- If you have no spouse and no children: Your estate passes to your parents.
- If your parents have died: Your estate passes to your siblings (or their descendants if they have died).
  - If there are no surviving

immediate relatives, the inheritance can go further out to nieces, nephews, grandparents, aunts, uncles, and cousins. If no family members can be found, your estate eventually goes to the State of New York.

These rules apply only to assets that are considered part of your "probate estate." Certain property passes automatically outside of the intestacy process—such as jointly owned property with rights of survivorship, life insurance proceeds with a named beneficiary, and retirement accounts with designated beneficiaries.

Dying without a will can create challenges. First, you lose control over who receives your property. You cannot leave specific gifts to friends, charities, or unmarried partners, because New York's intestacy law recognizes only spouses, blood relatives and legally adopted children as heirs. Stepchildren do not inherit unless legally adopted, no matter how close your relationship was.

You also cannot choose who will handle your estate—New York law sets the order of priority for who may serve as administrator, and it might not be the person you would have picked.

The intestacy process can also be slower and more costly. Family members may disagree about who should be in charge or how property should be handled. If no close relatives are available, the Public Administrator's

office may have to take over, adding another layer of bureaucracy.

Creating a will is not only about distributing your assets—it's about reducing stress for your loved ones. A properly drafted and executed will in New York allows you to:

- Choose exactly who inherits your property and in what amounts.
- Name an executor you trust to manage your estate.
- Appoint guardians for minor children.
- Provide for non-relatives or charities.

Without a will, your legacy is left to a set of rigid legal rules. While these rules aim to be fair, they cannot reflect your personal values, relationships, or intentions. By taking the time to prepare a will, you ensure that your wishes—not the default laws—guide the distribution of your life's work.

In short, if you live in New York, dying without a will means the state will write one for you—and you might not like what it says. The best way to protect your loved ones, your property, and your peace of mind is to plan ahead. Consulting with an experienced estate planning attorney can help you create a clear, valid, and enforceable plan that speaks for you when you no longer can.

#### Flood Insurance—You've Got This?

Picture this: your living room has become a wading pool, your coffee table is now an island, and your couch is floating toward the kitchen. Surely your homeowners policy will have your back, right?

In insurance-speak, a "flood" means water covering normally dry land—affecting at least two acres or two properties—thanks to overflowing rivers, tidal surges, sudden rainwater or snowmelt runoff, or even a glamorous mudflow. Your policy will happily pay for damage from a burst pipe but turns a cold shoulder to this kind of water invasion.

And don't break out the champagne if you're "not in a flood zone." Over 20 percent of flood claims come from homes outside FEMA's high-risk areas. FEMA's maps are based on historical data—great for trivia night, not so great for predicting

whether your street will become the next Venice.

That's where flood insurance steps in. The National Flood Insurance Program (NFIP) offers up to \$250,000 for your building and \$100,000 for contents. But for many homeowners this is not sufficient coverage. Private Flood coverage can offer more extensive protection and may throw in perks like loss-of-use coverage so you're not camping in your damp basement.

An insurance professional can help you compare NFIP and private coverage, so when the waters rise, you're equipped to bounce back—preferably without needing a canoe for your commute.


